CITY COUNCIL PROCEEDINGS BEMIDJI, MINNESOTA

Regular Meeting/Work Session - May 11, 2009

Pursuant to due call and notice, a regular meeting/work session of the City Council of the City of Bemidji, Beltrami County, Minnesota, was held on Monday, May 11, 2009, at 5:30 p.m. in the Conference Room of City Hall, Mayor Lehmann presiding.

Upon roll call, the following Councilmembers were declared present: Lehmann, Johnson, Negard, Waldhausen, Hellquist Absent: Meuers, Downs

Staff Present: City Manager John Chattin, City Engineer Craig Gray, Community Development Director Rita Albrecht, City Clerk Kay Murphy

Others Present: Mitch Rautio, Pat Donnay, Dale Thompson, Ade Mann, Al Belleveau and Cate Belleveau

Mayor Lehmann stated that the purpose of the meeting was to review the Central City Plan prepared by RDG Marketing.

Rita Albrecht, Community Development Director, provided an overview of how and why the marketing study was done for the downtown and south shore. She stated that the study cost \$60,000 and the funding was shared by the Downtown Development Association (DDA), City and Northwest Minnesota Initiative Fund. In March of 2008, RDG Marketing was hired and Central City Plan final draft was delivered in 2009 which staff has reviewed. RDG will make a formal presentation of the plan in June to the Council and at an open house for the general public. She stated that the plan is a valuable tool which can be used as the handout for interested developers as well as long-term planning for redevelopment of the downtown.

Mitch Rautio, DDA President, reviewed the list of things that the DDA does in Bemidji. He stated that the DDA has prepared a list of priorities, timing and funding plan as follows:

Rautio commented that Parking Lot #3 is in the process of being upgraded to improve safety and appeal. There are some business owners that have expressed concern about the reduction in parking spaces and he is in the process of meeting with downtown business owners regarding the chosen design for Lot #3. He stated that most business owners that he has spoken to are in favor of the new design.

City Engineer stated that the Council has already approved the plan and the bids will be going out the second week of June.

Ade Mann commented that parking is very important for business owners and he is not in favor of the new plan as too many parking spaces are lost.

Albrecht recommended that a group of City and DDA members review the plan on an annual basis and submit a report to City and DDA of accomplishments, upcoming initiatives and changes to the plan.
