## SECOND AMENDMENT TO PURCHASE AGREEMENT

THIS SECOND AMENDMENT TO PURCHASE AMENDMENT, is entered into this \_\_\_\_\_ day of November, 2016, by and between the Bemidji Economic Development Authority, ("BEDA"), and ICON Architectural Group, LLC, ("Purchaser").

#### WITNESSETH:

WHEREAS, BEDA and Purchaser previously entered into that certain Purchase Agreement dated May 3, 2016 (the "Original Purchase Agreement"), and subsequent Amendment to Purchase Agreement dated August 12, 2016 ("First Amendment") for the sale of the real property (the "Subject Property") subject of those agreements; and

WHEREAS, the parties desire to enter into a second amendment to the Original Purchase Agreement in order to extend Purchaser an additional two hundred ten (210) day period, beyond the initial 90-day period and 90-day extension (under First amendment), in which to conduct and complete Purchaser's due diligence investigation; and

**WHEREAS**, Paragraph 16 of the Original Purchase Agreement allows for amendment of the Original Purchase Agreement if set forth in writing and executed by both parties; and

WHEREAS, the BEDA is agreeable to extending the term of the due diligence period under the Original Purchase Agreement and First Amendment, an additional two hundred ten (210) days, conditioned upon Purchaser's continued compliance with the terms and conditions of the Original Purchase Agreement.

### NOW, THEREFORE, the parties hereto agree as follows:

- 1. On condition that it complies with all of the terms and requirements set forth in the Original Purchase Agreement as modified by the First Amendment, including its obligation to complete its due diligence investigation and execution of the Development Agreement with the BEDA prior to closing, Purchaser is extended an additional two hundred ten (210) day period within which to conduct and complete due diligence investigation of the Subject Property as Purchaser deems appropriate.
- 2. Said two hundred ten-day due diligence extension period to commence effective November 3, 2016, and expiring June 3, 2017.
- 3. Except as modified by this Second Amendment, all of the terms and conditions of the Original Purchase Agreement and First Amendment shall apply and be incorporated in this Second Amendment as if fully set forth herein.
