Consider Bemidji Volunteer Firefighters' Relief Association Pension Benefit

Mathews stated that City Staff have been discussing the 2021 pension benefit with FRA officials. The current understanding expires on December 31, 2020. Additionally, the Public Affairs Committee met on October 19 to discuss this issue and approved the recommendation for a 7% increase of \$7,850 effective January 1, 2021. The relief association is providing their own guarantees by maintaining a surplus position of about 125%. This provides a cushion against future market downturns, minimizing the risk of a required City contribution. Representatives with the Relief Association addressed questions and concerns with Council.

Motion by Rivera, seconded by Peterson approving the FRA annual benefit increase to \$7,850 effective January 1, 2021, including amending FRA By-Laws reflecting the change. Motion carried by the following roll call vote: Yeas: Johnson, Peterson, Rivera, Albrecht, Meehlhause. Nays: Erickson

Discuss Reopening of Neilson Reise Arena

Peterson stated that he has received numerous phone calls and questions surrounding rumors circulating in the community that the Neilson Reise Arena is not going to reopen on a permanent basis. Mathews stated that there has been no decision made regarding the arena and that council directed staff to draft a preparedness plan for the arena to bring to the public affairs committee for discussion and recommendation to council.

Motion by Peterson, seconded by Johnson, to reopen the Neilson Reise Arena pending approval of the preparedness plan for the arena by the public affairs committee. Peterson amended his motion to begin the process of reopening with the installation of ice pending approval of the preparedness plan by the public affairs committee. Upon discussion by council, Peterson withdrew his motion with the expectation that a public affairs committee meeting will be scheduled as soon as possible.
